Privacy Policy

Introduction

Specifically, we may use the personal information to help you with our products and services including but not limited to ongoing service and support, to communicate with you, to provide you information that you have requested, and to improve the performance of our services and overall visitor experience.

We collect this information:

- directly from you when you provide it to us;
- automatically as you navigate through the Website, which may include usage details, IP addresses, and information collected through cookies and other tracking technologies; and
- from third parties (including, for example, our business partners) pursuant to agreements between us and those third parties.

The information we collect on or through our Website is:

- information that you provide by filling in forms on our Website. We may also ask you for information when you report a problem with our Website;
- records and copies of your correspondence (including email addresses and phone number), between you and us; and

Security

We may retain your information for as long as your account is active or as needed to provide you services, comply with our legal obligations, resolve disputes and enforce our agreements.

Rights

You may update, correct, or delete your Account information and preferences at any time by accessing your Account.

You may decline to share certain Personal Data with us, in which case we may not be able to provide to you some or all of the features and functionality of the Service.

You may object to the processing of your Personal Data, on legitimate grounds, except if otherwise permitted by applicable law.
